PRESENT OUR IDEA OF A NEW EUROPE ON THE BASIS OF WHAT WE EXPECT AND WANT

EUROPEAN CRISIS

READ, MODIFY, IMPROVE

WHAT CAUSED THIS CRISIS AND SYSTEM IS TRACEABLE TO THE EURO AND TO ITS

MANAGEMENT BY THE EUROPEAN CENTRAL BANK AND THE CENTRAL BANKS THAT LED TO THE

COLLAPSE OF WHATEVER COSTS, FROM THE SIMPLEST TO THE MOST COMPLEX.

THIS CREATED A COMMON DEBT OUTSTANDING FOR THE ENTIRE EUROZONE, THE COLLAPSE IN CONSUMER SPENDING AND SOARING RETAIL COSTS, TOPPLING THE GDP OF ALL NATIONS AND DOING CLOSE MANY BUSINESSES, ESPECIALLY THE SMALLER ECONOMIES ENGINE.

THE PROBLEM IS MONEY, THAT IS THE ONLY POINT ON WHICH TO INTERVENE.

HOW TO SHAKE THE CURRENT STATUS:

- Reset of debt for all countries forming part of the euro zone or, if judged "absurd", block the bank interest, given that citizens of every nation should continue to do with absurd tax burden without being able to go out ever again, with repayment of debt owed to each country from 1 to 10 years, depending on the amount of debt;
- Remove all politicians current and past good or bad they are, great manager, and the "big old" control zones opting to improve their finances rather than being at the service of the European communities;
- Create a European Central Bank that handles fees paid by all euro-zone Nations without profit gain but excessive, like any organization that operates in any field; understand that banks are citizens, not the citizens of banks; all the money that will come and will come out from this Bank will be controlled by the "great minds of Europe" that will see and assess waste and abuse. until the "big old" will be part of this system there will be a future for us, but only for them;
- 20% tax to all nations of the Euro zone; a 5% of Fund that will create a "piggy bank" able to handle all the calamities that have occurred; a 5% to pay all civil servants; a 3% for health, a 2% for the army; 2% on investment funds for vital management with global stock markets, which, however, is called "investment", and remains a portfolio;
- The money will be managed proportionately and divided into parts perfectly equal among all Nations, in proportion, of course, to the extent of the territory: es. "If Germany has 357,000 km2 of surface, 544,000, France excluding overseas departments, and the 302,000 Italy, if Germany will allocate funds for the renovation or construction of 357 km of new roads, for France will be allocated funds for the same reason but on a basis of 544 km, Italy will be allocated funds for the same reason but on a basis of 302 km and these funds must be appropriated immediately and for all the Nations of the Euro zone;
- Over the years can estimate an increase of the public through taxes, starting from the bottom up, not from the top down, as the crooks will not allow the reduction of taxes, but also assess their reduction or redeployment where serve more investment;
- All expenses that will be carried out with public money must be communicated to the penny, that citizenship cannot actively participate in the decision of what, according to them, is a priority and what is secondary, since it would not be a deal, but must be updated on all expenditure in real time;
- Remove Golden pensions, annuities and salaries that do not conform to the heavy European crisis situation but, more importantly, to ethics, removing all those categories that have bonus rewards Governors incapable, or rather, quite capable and furbissimi in everything to exploit personal advantage;
- Restructuring of American-style Governments: one just "decide", in accordance with the imput it receives from those who manage the areas that will be the real policy makers of everything that is going on, how to get around and what to risk. All other figures "useless" are replaced by "great minds" operating in every sector;
- The debts of all the euro area countries with other continents should be extended to "common European debt" and healed and cleared in less time.

OTHER FUNDAMENTAL FACTORS REPORTED TO BE EVALUATED, "IMPORTANT", NOT FUNDAMENTALS.

Note:

for "important" team, "big brains" team, "great minds (national)" and "great minds of Europe" refers to the highest level of graduates that will create teams of graduates of countries, cultures and religions that are able to keep scribbling on paper, but only realizable projects, eliminating all the old and corrupt present. Their appointments will be ten-year maximum and cannot exceed the mandate at the end of the age of 43 years, with fees that they will never overcome, for European summits, 4,000 euros gross. For national leaders to 3,100 under the 2,300 team. At the end of the mandate will be "recycled" within companies on national territory. This will allow you to enter new and highly qualified forces, revolutionary and innovative instead of useless fillers. Places will be allocated to those who demonstrate ability and innovative growth already at university level and internship, without difference of sex, culture, religion or recommendation. Then with natural selection, with no chance of error and every mistake will be easily found.

There will be no more need to make mega and costly election. Will be elected one Governor or head of State for every nation that will have the task of extra negotiations.

All figures or percentages that are reported, are to be seen and evaluated by "team of great minds of Europe" who will decide, through their studies, what actions to take.

ALL NATIONS MUST IMPROVE THEIR TERRITORY MAKING IT safe and TECHNOLOGICALLY, EXPLOITING and ARCHITECTURALLY advanced (anticipating the future without waiting for it to arrive).

What RAISES:

This generates work for all businesses who will be engaged in all types of manufacturing, research and development for technologies. Jobs for urban and extra urban infrastructure will run, to avoid too many extraordinary maintenance interventions, with the best materials, technologically advanced, exploiting and architecturally significant and, certainly, earthquake-resistant and anti calamity, anticipating the future.

This obliges companies to find qualified personnel to create "big brains" team, which, with regard to an educational reform, will allow students from all Nations to give up with desire and passion, bringing educational staff to stem growth not indifferent, because tomorrow may be "important" team. These teams must have decision-making power and effectiveness of structural problems solving, technological, engineering and architecture. In addition it would generate a lot of manpower at all levels that will create significant business volumes for all the national armature (purchase of new homes, cars, tourism, etc.) and financial, for credit requests.

The work will increase so much that everyone will have the opportunity to earn the right and have the obligation to upgrade their properties to make them functional, technological advances with polluting materials close to 0. European decisions should include important infrastructure works, giving priority to what can become calamities, which offered security of mountains, towns, roads, infrastructure (how to remove all asbestos still occasionally present, or how to avoid or leads the drought by creating irrigation channels perhaps by exploiting and purifying seawater or, in places that cannot be reached from the sea, creating large reservoirs to securing, in summer, to limit costs, streams, large or small, to prevent flooding and, therefore, "unexpected" in rainy seasons.

Calamity.

In case of disaster, the entire nation that suffers the event will help, especially with the national body-related forces, but also with outside forces "occasional" (es.: all institutes will put at your disposal, disaster relief, young people from 16 years to undergraduates, full of strength and spirit, able to work as over the years it has been shown, their workforce for a week. The European Union will be obliged to create positions for transportation, which will be free, housing, even in tents, and the food (kitchen furniture). This will make it clear to young people the importance of the community in which you live and will understand the orientation to work and operate in teams. You will have a reward estimated at a quarter of high salary, 2,200 euros, so the perceived of 550 euros will serve them for the purchase of school supplies and will be run by the institutes. Same for convicts, active retirees).

All Nations will only use its territory for companies producing everything that will serve to carry out the works themselves, from the smallest detail to the more challenging, without buying products from "sisters" or poor Nations and cheaply from other continents by way of "underdevelopment" and "enslaved" (this will help entire

populations from other continents tirannizzate and exploited for the benefit of few ragavan increasingly enriched).

All enterprises should be in step with **the environmental situation** by improving the State of the regions hosting them and generate data that could show the pollutants on a quarterly basis and notify the team of "great minds" who will report to the national "great minds of Europe" reports and assess pollution differences between companies which do the same job in all European countries and present Governors high-risk situations order to assess immediate interventions. This will avoid the most polluting companies jump out after decades of damage caused.

Every work to be carried out must be viewed and corrected by "team of great minds" that will evaluate the urgencies. The costs for the construction of the works to be implemented must be reliable and without wasting time and never entrusted to undertakings ' relative ' or implausible they can declare bankruptcy but only to companies that deliver the works finished and realized. These costs will be viewed and evaluated by "important" European team of "great minds" that will evaluate the diversity of costs between nation and nation for the realization of works, taking into account the materials used and the relative costs of production of the latter, by communicating to the Governors variability of important production costs compared to the costs of other nations of the euro zone and by reporting suspicious or substantive diversity on bulging costs same as domestic suppliers.

All the works to be carried out will be supervised by team of "great minds" gathered from around the country (one for each country from the North, one South, one from downtown to prevent infiltrations) which will follow the completion of the works from start to delivery, step by step, by evaluating and analyzing, day by day, every material that could be used to carry out the works to certify the adequacy and technology and control units at companies that have production mandates useful parts to the realization of the works themselves. All companies that develop technologies that may be relevant, are rewarded not so much monetary level, which can be home, but above all in terms of brand, positioning them as examples of European business summits, and will have a say in the works to be carried out, presenting their projects.

The works of less importance or of urban landscaping or extra urbano, will be developed by each region through sponsorship by large companies or with the help of individuals who will have the obligation to enrich, depending on income, regional territories hosting them.

All Nations must provide for the creation of important **farming areas**, selecting the most productive areas, and animal production, creating spaces for animals and technologically advanced for their "well-being" and the quality of their production. The "great minds" here dedicated to importing innovations that protect domestic products and especially pollution, taking as an example the existing structures that are able to produce electricity, natural and other fertilizers, autogestendosi and producing value, creating technological and logistical bases for sorting of products across the euro area. In these territories there will be "great minds" that will examine the quality and authenticity of the products. Decide, as a result and according to the real production costs, the cost of the product throughout the euro area and will, in addition, the territories to see if direct industry operators need funds for development and if they really suffer damage from natural disasters and what will be the amount of recoveries.

Trade can be made between "Nations" sisters, among those with a particular product and those who cannot, for cost and environment, begin a production, while the extra export will be managed by the European "great minds of the European Community" that will communicate to the Governors at that price is agreed the extra sales.

The vast majority of **transportation** will be handled through innovative transport with the lowest possible environmental impact, creating new sites and logistics infrastructures, developing the rail and maritime sector between different countries, so as to avoid pollution and excessive road traffic wherever possible.

All road transport should be overhauled, creating specific lanes for goods and new innovative means to be at very low environmental impact.

The raw materials to be purchased at other continents will be purchased from European and national basis, so as to increase volume and reduce costs.

If a European nation possesses raw materials not present in other European countries, the cost of these will be established for use by the European Commission of "great minds European decision-making" and the purchase price will be the same throughout Europe. These will decide the cost for export to other continents, if any, of these resources and quantities that you can export, taking into account the need of these resources to meet the euro zone and will communicate to the Governors the price for extra sales. This to create a territorial wealth for those who possess but do qualify, as a percentage, even across the euro area, not delivering funds to the Nations, but creating another Bank Fund.

National production of private goods (food, textiles, energy, etc.) will be handled directly by the companies who decide the costs for exporting these products Paolo. For Europe, the costs will be managed by boards of "great minds European decision-making" and will be valid throughout the euro area, but certainly lower export costs extra. This will increase the tourist business from extracontinentali countries to Europe to purchase various products in the territory of the same production and increase purchase volumes on the part of European citizens.

The management on the cost of electrical supplies, gas, methane, telephony, ADSL and other important supplies and their expansion will be governed by boards of "great minds European decision-making" and will be the same throughout the euro area. These are first of all to zero then decide what will be the cost of notice to all companies that manage these fields, and will, therefore, way of creating competition based on earnings that will want to get their products always with roofs and limitations, and citizens will have a real choice. These their earnings, in addition to personnel management and infrastructure, will be used to expand the technology projects that will lead to innovative products, environmental improvements and savings for consumers. The products that all houses must produce only the best should be as energy class, pollution, consumption and savings but also developed computer level.

Private companies will continue to have their private earnings. All, however, exceeded a certain income ceiling, depending on the quantity and quality of their personnel, which will be decided by "great minds of Europe", must show their ethics by creating fictitious companies to split the proceeds, but by creating or developing major infrastructure such as hospitals or family houses for relatives of serious patients at hospitals or anything else that can serve the good of the community. Although, for minor businesses, cutting-edge equipment. These structures or equipment will carry the name of businesses that have donated to the society.

All Nations must create structures that have an obligation to seek out and develop **new technologies**, with close to 0 environmental impacts with regard to electrical supplies and related to alternative fuels, pointing out the pros and cons of their projects, communicating with Governments who will view and new projects to "great minds of Europe" that will evaluate the possibility of developing the best proposals.

All new discoveries, which will bring savings and innovation, will be "implanted" in each country. These have, in addition to production costs, no obligation to "purchase patents" of those found since all nations have participated in the development of that research.

All enterprises which have brought their productions in continental countries, if they want to, they can restore their territories of origin production by paying for the return of . 25 tax spared from their expatriation. If, for example, have operated in other continents for 10 years, will have to pay, under the last two tax returns filed, 2 and a half years of contributions and the payment will be divided into five years.

Fuels.

The cost of fuel will be equal to the whole of Europe and the purchase of oil will be made, as for raw materials, by the European Community and no longer by any single nation to increase the amount of the product and improve the purchase and distribution costs. Most will not need to have any additional cost for taxes, for various disasters, since they will be absorbed by 5% paid to disaster fund for other expenses. Only the "great European team" will be able to assess the extent of damage created by natural disasters and for rehabilitation of the affected areas in collaboration with Governments, bearing in mind the community first, then town planning and finally the monumental, but using exclusively the disaster fund available to the European Community.

Public transportation will be handled only with means and cars polluting impact close to absolute 0.

The construction companies, civil purposes must comply with the best world standards. The buildings, from the popular to the more stately urban high-rise, projects must be approved by the "great minds" that will assess the logistic part where you want to carry out the work if it is suitable for construction and production costs at

European level, avoiding fraud to the end user, and all technological and security features that "great minds of Europe" have decided to have present in new buildings, before authorizing the work. The "important national team" (North, South, Centre) paid by the same companies, which will have to carry out the checks, will oversee all the types of materials that will be used for construction of buildings, on the same level of commitment that you will have to carry out the public facilities. Each contractor will declare the cost which will support for the realisation of the works to the competent bodies, and will check the sales and earnings from make: e. g. scissors between 15 and 35% gain on products manufactured on the basis of how many enterprises will operate for the implementation and realization of a given structure. If a company manufactures A to Z will not have a gain higher than the 15% net of costs. If will be more business for the realization of a work but due to the same family group or similar, commissioneranno enterprises, to which, however, will be granted a 15% gain if the works are still in good standing.

Businesses that do not comply with standards for materials and everything else will be deleted from the national CHAMBER of COMMERCE, and will not return with fictitious owners or other stratagems.

No contractor can deflect any kind of issues relating to buildings. The emergence of issues the constructor, with all firms who have collaborated to the realization of the project will answer the problems to be solved or damages. In the case of bankrupt enterprises, with their goods, even if made payable to family members. This will allow maximum seriousness and honesty on the part of those who will work for the common good and not lose their personal assets. Anyone who thinks only to gain leave to other problems, or will respect the new ideas or work will change.

This applies to builders as for all other companies, none excluded, operating with the interlocutor cittadino ultimate final consumer and always be protected as a principle.

Costs of **insurance**, to movable and immovable property, of the person or of any other insurance option, you will have a European basis which will assess the costs using the sector studies carried out by the "great minds" and on "great minds of Europe" that occurred the same costs, will raise expenses that citizens will face, the same for the entire European areawith the variants for the areas most at risk and with different population densities.

This will generate a substantial and drastic fall in spending costs for every citizen of every European nation. The "great minds of Europe" will have "important" team that will view the costs that the community faces, to report huge costs between production and retailing, cautioning companies that will not cost justifiable for greed of the entrepreneurs themselves. Companies with European warnings, will be monitored for six months by European specialists but not the country where the company resides, to evaluate the real costs and revenues by controlling the fiscal situation and making it all fit in the parameters; the standards of commercial gain, to the final consumer, should not exceed a certain percentage of income (e. g. scissors between 15 and 35% gain on products manufactured on the basis of how many businesses will work to produce that particular product).

This will allow all European citizens to be able to buy better prices but higher quantity and quality.

The money.

The cost of money is agreed centrally between banks of all Nations and the European Central Bank; national banks and consumer finance companies will purchase money all at the same price (e. g. 1%) and may sell it to companies with content that rates should not exceed 1. 5% gain, which will need to manage their businesses in their entirety; consumer credit must not be more than 3. 5% rates but will handle sales of optional services own personally. Banks that will disagree, given that they had great earnings untraceable immense aid to survive and still been able to create the situation that today we live in the world, can close their doors. Create a new banking situation is possible, given that banks are citizens who deposit or invest their savings. By blocking these operations we can close a bank.

All **salaries** for policy makers and managers "(governors) of individual Nations and of United Europe", "great minds", "the great European minds", should be "bearable" for the community and never out of the top, keeping the same for all countries. Will, in addition, assessed all areas of professional and treated with appropriate fees. E. g. If an architect now wants 10% on the cost of production of an artwork can try their luck outside Europe. If you will want to keep their earnings, they can accomplish their work in favour of individuals and ask for compensation that they think appropriate. All the works to be carried out, although in favour of individuals, however, will always have the placet of the "great minds" that must always assess all points to a realization

always safe. The same applies to all other categories as a notary public who requires disproportionate figures for a signature on a document, or as a doctor for "oath" should first treat and not worry about his absurd plots, and so on for all the other categories. So you can wipe away all kinds of extortion, even these indirect, and introduce new figures of "great minds" or new graduates who will occupy these positions. In the euro zone will be established on the basis of salaries roofs Office but with maximum gross and roofs not exceeding 5,000 euros for the Governors. Same thing will apply for other categories, such as notaries, and specialized doctors, University professors and all other professional groups, none excluded. The "details" will always be supervised.

What is certain is that, however, who wanted to create a company on his own to try and develop its services is free to do so.

All these people who work with the private sector must take account of their compensation and, if you don't wish to accept changes will have alternate fiscal controls "great minds" but fixed in their consulting studies, to evaluate the real earnings and any escapes; Community citizenship may apply to new emerging levers to improve their expenses which, as, will replace those categories that won't want to adapt. Let us remember that much work benefits at all. If you just eat a lot, for many there may be, for many consumers, there will be, however, even the possibility to avail of services.

We avoid that categories that have exaggerated over time in the demand for excessive compensation, can continue in buy "the world" with the money of people who struggle to see not the end, but the middle of the month.

All European salaries shall have the same contractual bases in all countries of the euro zone. Enterprise to enterprise, sector by sector, will be the "great minds of Europe" to decide which salary should perceive the worker of a given sector. If that sector should recognise an increase, for seniority or whatever it is, this increase will be uniform for all workers of all Nations to that sector. Of course, businesses will have the opportunity to reward their employees for work performed, having personal Enterprise revenues, may do so but with all the same taxation arrangements already described, without concessions or peculiarity.

Immediate elimination of the COOP ("cooperative members") or similar, they eat, not allowing him entry workers in the world of personal credit and living for tax evasion and avoiding changing controls every little name.

Prisons.

The prison management will be easier, since the development of this system allows a lower propensity to crime, because that would create a civil situation more livable and quiet, with much more work available and many more controls to public order.

Structures, of course, must be managed in the best possible way with staff at the height of the work that is going to play. The prisoners will be the first resources from which to draw. This is in case of reclamations or put into works to implement rule or restore national in case of natural disasters.

Cannot absolutely be sure forces in one closet, but must contribute to their reintegration into community life.

Immigration.

Assuming that, of all persons residing on the continent of Europe, Europe and beyond, all should be registered by depositing at eligible facilities fingerprints and DNA, in order to be able to recognize those who taint of serious crimes and at the same time drastically reducing crimes that need this type of information when resolving cases, from robbery to murderand the same should be done for anyone coming into Europe from any port. Immigrant citizens residing in a European nation, after five years will become, if you will, European citizens in all respects and will have the opportunity to participate in community life. Children born in the territory will have birth, citizenship or dual citizenship if they wanted to maintain roots with their origins.

Foreigners who enter illegally, according to their personal situations assessed, will be repatriated.

Instruction.

The "great minds of Europe" must address, year by year, students toward a diploma, according to market demand, that qualified personnel whose resign you will need, by reducing or blocking the sites that have too

many subscribers and with graduates or graduates already on the market, thus avoiding obvious blocks for future job opportunities.

The school year for the colleges, then after the first eight grades, will be divided into ten months, is no longer about nine months.

All pupils, from reaching the sixteenth year of age enrolled in school addresses chosen by students, at certain times and managed from the "great minds" of the institutes themselves, should begin to offer a monthly internship at national enterprises, including national-owned (public), which will be created to verify subscribers if educational choices that they made to their capacities are suitable and to let him know the work in its entirety. The products obtained from their work, will be sold whenever possible and revenues, excluding service charges, will be made available to support education. This until the last year of study. (es.: who he enrolled at the Faculty of medicine, will have to follow a training course "active" in the structures, to know the reality of the situations and understand the dynamics of the work, other than the theory.)

More talk and 'sport variant: everyone must follow courses, sports of all kinds, depending on school location.

The institutes will be the technological, engineering and more architecturally "only" on the basis of the best European institutes.

As already said: students from all Nations must give up with desire and passion, bringing educational staff to stem growth, because a significant tomorrow can form "team". There will be no more graduates or graduates without jobs.

The army.

We are not war Nations and only be developed theories for peace for the Betterment of life.

The army will be United forces of European Community whole, coming equally from all Nations, always based on population density, but their work must be based fundamentally on developing new technologies and researching space flight; keeping them, as well as by percentage of fees (2%), will come from sponsorships, visible and traceable for everyone from the largest business groups in Europe.

The European basis, through the "great minds of Europe", can sell and then put the world at your disposal their patents and innovations by self-financing its research and development sector.

At the other end of the army will have a duty to intervene in areas affected by natural disasters to bring relief and, above all, specialize their areas disseminating health level, building, engineering, and technology in all areas where it will have to act to bring relief. Be the first to step in and lay foundations for civil reconstruction (housing and roads, not tents) first of all, enterprises soon after and, finally, of the monumental part.

Will, of course, supervised by "great minds" for each field that you want to restore.

The Nations will create unique specialized bodies which internally will provide territorial control, amalgamating all those sottocorpi duplications (e. g. – for Italy - police, carabinieri, guardia di finanza . . .) or that do not have force of survival (municipal supervision type, Red Cross, etc.) eliminating bureaucracies and logistic positions duplication and poor cooperation and increasing the number of control forces based on population density. The penalties will be the same for all EU countries. There will be no added costs from municipalities, provinces, regions, non-uniform national system that can generate doubts about the actions of the controllers.

This national body for each nation, won't have insurance costs for structures and means, important not to have other expenses that are borne by citizenship, and will be remitted of all disposable cost (e. g. registrations or steps owned vehicles will have no cost and all means have the same plaque bearing the name of the country).

The technology will be the basis of these specialized bodies and will be created, developed and made available to "national bodies by the combined forces of the European Community", the European army.

This body will have the obligation to be stationed in cities where lawlessness or noncompliance with the rules is Mistress towns. Numerically massive force will administer these avanposti day and night making them the safest possible and, initially, will examine the territory to "reclaim".

Medicine.

Only the "great European team of researchers" from all European countries in equal numbers, always based on population density, will carry out reasonable research and the development of Pharmacology will be only in Central Europe, to centralize, halving costs expenditures, eliminate products that bring only benefits to large multinationals and do great work with maximum results.

The "great minds of Europe" must keep the cost of medicines that will be the same for all Nations and decide, especially, which medication will be put on the market and what to be deleted because it duplicates or insufficiently tested or unsuitable to treatment related or especially with cost of sales is not justifiable.

For research and development, which will be at the European level, i. e. the same army rule: medical discoveries will be made available and the sale of their patents will serve as a self financing for research and development in addition to the percentage of taxes that will be paid for their livelihood (3%).

The Team of "great minds of Europe" from all nations together, will the development of the sector and to carry out searches by bringing results with biblical times but more than assured, creating teams that will carry out the studies started for each sector.

In addition to the European Community that all citizens should try to allocate members quotas through annual grants or calls for solidarity and development research since this is a common good and, therefore, for the benefit of all.

Research and will have funding structures that come directly from the European Central Bank, and then at a rate that is the same as national banks, and will use these loans for the purchase of technological equipment, which will be more present throughout the national territory, and for updating the present or new structures.

All medical facilities on national territories should be privatized but under control of "great minds", and payments of admissions will be made privately, via ticket for every citizen according to gravity but always according to the income and the amount of expenditure to be supported per citizen, with percentages that will be laid down by the "European" great minds.

All subjects should be kept under standard control: every citizen, every 3 years, from exceeding the threshold of 30 years, will be subjected to TOTAL control, to assess health status and any at-risk situations on which to act quickly at new structures specific managed by university graduates and trainees. This will allow immediate interventions can improve healing times, and long treatments cost-saving shut-off from their training.

Citizens who have specific medical performance needs and continue, will not be subject to immediate costs. Every six months, a structure devised from "great minds of Europe", will, through documentation of income and medical expenses incurred, to establish a payment, depending on income, if necessary.

Each region, through the supervision of the "great minds", which will create their "important" team of supervisors for each facility, always coming from more areas of the country, will have to keep under control the structures making them the most active and productive technology possible, taking away waste and interfacing with the "great minds" that European will evaluate each Nation's costs for all the medical expenses of all facilities and equipmentby communicating to the Governors themselves when Nations notice wastage or malfunctions; the "great minds" will create new manufacturing facilities for updating technological and engineering development or visit and evaluate existing updating them.

Individuals who wish to keep their clinics and develop the search scope in their structures, will be free to do so, however the results of their research at "great minds European medical". As with other companies, even in the case of these important findings, will European recognition in recognition of brand.

If the medicine becomes a showpiece, worldwide can benefit them and intervene by purchasing innovative medicines, and major equipment projects and thereby developing the sector further and relentlessly.

Justice

Justice must be reformed because it undergoes too much external influences and operators perceive inadequate parcels at the time: a European Tribunal who serves does not have national pressures or internal policies that could alter or even worse undermining the decisions taken by major crimes, such as extortion, murder, fraud against the State, extradition, murder, kidnapping, mafia and others on this level.

Each region will have a tribunal consisting of at least five judges from five European Nations plus a panel of attorneys who will be composed of one representative for each nation State in Europe that will bring its findings to a court that will evaluate and will issue verdicts.

Less important causes, will be handled by national courts with national juries.

The simplest ones directly witnessed by three judges for trial.

The judging, judges and juries, cannot have an aged over 60 years.

The costs of processes, including judges, lawyers and the entire collection is restored at the level of fees and execution times and simplification of procedural deadlines.

Everything else can be developed from "great minds of Europe" in the sector, who will know how to develop a sector to be renewed. This will also include the renovation of the laws that are no longer "ad personam" but really the same for everybody.

Society As A Whole.

All European citizens will have a single electronic identity document that will have its cip useful documents, like identity card, driving license, passport, family status, various certificates. This document will be updated every time a citizen will make a request for release, the issuer who inserts in cip. In each location where you will be prompted by a document simply deliver this badge and each institution will be able to verify this through its terminal.

The goal is that with perfect management of the project "NEW EUROPE" will retire by 60. Even retirees must, however, have a task for the community. Must, always remembering that our seniors complain about the boredom of their days, be moving to get mind and body active. According to the main job held, give community service for at least 16 hours a week, certainly not in the form required, but only help level and provided with adequate physical and psychic characteristics (e. g.: follow students who need help, to cook at school canteens or other, follow or help seniors or those who have physical difficulties at specific centres as "the sick", be vigilant at educational institutions from nurseries to universities, manage and maintain the communal areas such as parks or gardens, . . .).

All work will mean many more families need dedicated infrastructure, most need help. The "grandparents" must be part of this community.

This proposal will have plenty of work available, create countries perhaps very similar but definitely efficient and effective, clear differences between nation and Nation, region and region, town and municipality.

All Nations who won't want to join the "new Europe" plan will get out of it without damage. All companies must collaborate for maximum growth and technological development.

No head of State or political office or anyone else, can respond to the proposal of this "NEW STATE" without having asked his people to know what you think, if it's safe to rebuild everything, restart all from scratch or remain in a situation of poverty that we are many in which we were brought by a few, and entering in "PROJECT EUROPE" amendments that they believe you should evaluate.

Each nation will ask all its citizens, then all the real owners of Nations, a judgment on the "NEW EUROPE".

Should not be a vote, toward which many look so hopeless and, therefore, in abstaining, but as a census, where there are abstentions. The information must be presented to those who have achieved sixteen years of age onwards. All must submit a copy of a document signed and sign the "project" to read.

A trial of improvement proposals by every single citizen can make a difference.

We create our State Europe.

All together we can improve the State of affairs in which we live.
